# EURODAD Senior Policy and Advocacy Officer, Debt Justice Team

### Reporting to: Policy and Advocacy Manager, Debt Justice

About Eurodad: Eurodad (the European Network on Debt and Development) is a network of 60 civil society organisations (CSOs) from 28 European countries, which works for transformative yet specific changes to global and European policies, institutions, rules and structures to ensure a democratically controlled, environmentally sustainable financial and economic system that works to eradicate poverty and ensure human rights for all.

Role Purpose: The purpose of this role is to work with Eurodad's debt justice team to take forward the crucial work of preventing and resolving debt crises, and pushing for fundamental reforms of the international financial architecture. The role primarily involves coordinating and producing robustly researched analysis, with a strong advocacy focus. The role also requires contributing to build strong and effective coalitions for change, helping to empower civil society organizations in Europe and beyond.

The successful candidate will work at the cutting edge of debt and development finance campaigns and advocacy for transformative change. They will require high policy analysis skills with strong interpersonal communication and be self-motivated with the ability to plan, organise and implement activities under their own initiative. They will have experience working with advocacy focussed civil society groups or similar organisations and have a good working knowledge of relevant international financial institutions.

### JOB DESCRIPTION

### A. POLICY MONITORING, RESEARCH AND ANALYSIS (35%)

- Design and conduct advocacy-focused research (both quantitative and qualitative), country monitoring, case studies and policy analysis on relevant debt justice issues, including sovereign debt crisis prevention and resolution, debt sustainability, IMF programs and policies, international financial architecture reform and impacts of debt distress and austerity on human rights, gender equality and sustainable development.
- 2. Produce reports, briefings, articles, updates and summaries based on research and rapid policy analysis on current sovereign processes, policies and practices.
- 3. Coordinate the production of joint reports or position papers authored with allied organisations, including developing joint methodologies, editing and identifying joint conclusions and recommendations.
- 4. Keep up to date with key issues, including monitoring relevant official and civil society activities in policy areas identified as network priorities.
- 5. Support the mainstreaming of gender and climate justice into debt justice team research and analysis.

### B. ADVOCACY AND NETWORKING (30%)

- 1. Contribute to developing Eurodad's advocacy strategies in key areas, jointly with the rest of the debt justice team, Eurodad membership and global south partners, and develop implementation plans.
- 2. Organise and lead advocacy meetings, including with politicians, officials and parliamentarians.
- 3. Present Eurodad's work at conferences and seminars.
- 4. Organise, facilitate, attend and report on meetings, conferences, teleconferences and other events, including with Eurodad members and allies, including to agree common strategies and activities.

### C. INFORMATION SHARING AND COMMUNICATIONS (20%)

- 1. Respond to questions from Eurodad members, partners, allies and others on key issues, providing support for policy and advocacy activities.
- 2. Author and edit content for Eurodad's website, newsletter and other communications channels, and for external publications, including helping to ensure effective dissemination to relevant networks and individuals.



3. Play an active role in ensuring effective communications strategy and outreach including designing dissemination strategies.

# D. POLICY TEAM COORDINATION, PROJECT ADMINISTRATION & MEAL (15 %)

- Support fundraising activities, including by drafting relevant sections of fundraising proposals and reports to donors.
- Support the organisation and documentation of meetings, conferences, webinars, teleconferences and other processes.
- Contribute to regular work and strategy planning.
- Contribute to the Eurodad's debt justice team's Monitoring, Evaluation, Accountability and Learning (MEAL) systems.
- Contribute, as part of Eurodad's team, to building team spirit by supporting colleagues and assisting with the day to day running of the office.

## ROLE RELATED EXPERIENCE, SKILLS AND KNOWLEDGE

### 1. ESSENTIAL SKILLS:

- Politically astute policy analysis skills, including an ability to analyse policy developments and develop strategic advocacy positions aligned with Eurodad's vision and theory of change.
- Strong communication skills with a very high standard of spoken and written English.
- Excellent interpersonal skills and collegial approach, including tactful but effective facilitation to build consensus.
- Strong planning and organisational skills, particularly the ability to plan and execute research that contributes to advocacy strategies, and ability to prioritise, exercise initiative, and work both with a team and independently. Motivated team player, with a focus on supporting the team and Eurodad partners to achieve objectives, combined with ability to prioritise, use own initiative and work independently.
- Ability to work in and adapt to a very dynamic external work environment, with a diverse and changing network of stakeholders, working in different time zones.

- Excellent understanding of debt justice, economic justice and development finance issues, and related policy and political debates.

- Ability to make complex topics accessible and relevant to policy audiences, including writing succinct and well-structured outputs.



- At least 5 years of work experience of:
  - Research and analysis, writing briefings or reports on international development finance, sovereign debt or related issues.
  - Working on policy, advocacy, or campaigning, ideally in a civil society organisation, particularly working as part of coalitions or networks.
- Educated to at least degree level in political sciences, economics, development studies or a related subject.
- High level skills in processing data in excel and other software. Computer literate and familiar with standard software, including MS Office, Google workspace, amongst others.

### **3. DESIRABLE EXPERIENCE**

- Understanding of climate justice and gender justice issues.
- Professional or voluntary experience working with organisations from the Global South.
- Professional or voluntary experience working in a network and/or with racially, ethnically, LGBTI, disabled and/or socioeconomically diverse communities.
